2024-04-08 Graham and John discuss the who pandemic treaty...

G'day everyone, Friday the 5th of April, recording a fantastic interview with some incredible people. Uh, joining us today, John, isn't it great to have these two on? Yeah, long awaited. Uh, we've been, uh, obviously we know Katie, but, uh, she, she's a, almost a regular, but, uh, we've got Robbie, uh, Peterson on for the first time and I've had numerous conversations with, uh, Dr.

Robbie Peterson on the phone, uh, but never, uh, been lucky enough to, to, uh, talk to him in the flesh. So this is a great day. Now, this is a great day because Robbie is going to get Sam Newman on this program, uh, former football grade from Geelong, the cats. Uh, and that's good because any friend of Sam Neumann's is a friend of Sam Neumann's.

I used to work for a boss at uh, Qantas who's uh, James Strong. He was amazing. He memorized people's names. You might bump into him in the terminal three years after you first met him and he remembered your first name. He was incredible. Um, but uh, yeah, he used to say anyone who says they're a friend of mine to gain advantage isn't.

So that's a good sign for us all to go by. Anyhow, what are we here to talk about? We've got, uh, we do have Robbie Peterson on and welcome Robbie. And we have Katie Ashby Coppins who's come on to talk about a whole bunch of stuff. We've, uh, we shared a screen with Maria Z just a week or so ago, Katie. And, um, boy, we unpacked some great stuff.

You're here to represent the Alliance Council of Australia, of which Club Grubbery is, is, uh, very proud to support. And, um, and we're looking forward to unpacking a whole bunch of stuff. Now, before we get into. The main topic, which is of course, we need to get out of the hood. There's no doubt about it. The World Health Organization, uh, Johnny, it was great to hear Tony Abbott, former prime minister in the interview we did just a few hours ago, pretty much say exactly the same thing.

Yeah, he said that he doesn't go much on conspiracy theories, I think, but, uh, he thought that those organizations really didn't have a lot to offer, uh, and I think proof's in the pudding. Uh, what have they done? Uh, they're just, uh, big show ponies that are, uh, that are, uh, taking. money and not doing anything productive with it.

In fact, they're counterproductive. Yes. And apologies to anybody who may be watching this while they're eating their meal. That photo behind, uh, behind Katie is enough to make most thinkers want to vomit. Uh, but it is what it is. Um, them and not them. Very interesting. Well, to me, they're all in the same bucket, but let's not go there.

So let's start with you, Katie. Um, what, what you're doing is very, very, very important. I want to know who's behind this organization, who set it up and what your main purpose is. Yeah, well, thank you so much. And it's so great to be with everyone today. Uh, Aligned Council of Australia, uh, really came together.

It's, uh, Dr. Peterson's, uh, brainchild, uh, and it really arose out of the terms of reference that Julie and, uh, Gillespie and Peter Pham and a whole lot of amazing people, uh, helped, uh, right over the Christmas period. And what happened there was a whole lot of groups came together to put their, um, name and support behind the terms of reference and that of course was a full terms of reference for a full royal commission so that we actually get answers about the last four years.

As a consequence of that fantastic feedback, a huge number of people supported it to sign the petition. Dr Peter Singh came to a A couple of people have said, well, why don't we do this with respect to exiting the W. H. O. We've got a lot of different groups doing lots of different things. We're all a little bit disparate, but we're all doing great things.

But sometimes we have no idea about what those other groups are doing. So really out of that, um, Uh, a CA or Aligned Council of Australia was born and in a short time since February, 2024. So only a few months. Uh, we've managed to pull together, I think we're up to 31 groups now, and we're about 1.2 million members, uh, all up.

So we are bringing together the groups. We are only focused on the WHO, uh, pandemic treaties and the rejection of those, uh, to do anything else, I think right now we would be diluting our. Uh, efforts. And really we're simple. Uh, we've got three goals to communicate what we're all the groups are up to. To coordinate what all the groups are up to and then to disseminate that information to the groups so that you know, we can't get censored when we share this information amongst ourselves and effectively like a whisper campaign.

We're able to get that information accurate information out there in a much more user friendly form and not face this. censorship and issues that we've been facing. So that really is our goal, uh, to inform the public, to inform politicians, and make this an election issue. And that's what the picture in the image is behind me.

Australia elected, uh, these guys, not these guys, and we won't be able to vote out the WHO. So true. As much as we'd like to vote out the other guys as well. But anyway, um, look, you know, we're, this group is amazing, Robbie Peterson, because there are a lot of disparate groups out there trying their very best.

Everybody's attacking the, the elephant from a different angle and we're all doing the best we can and most of us are staying in our lane. It's really important that despite all of this and despite all the rhetoric about other issues and agendas that we stay focused and work with what we've got to start with.

I mean a lot of people are talking about we should be um, you know, we should be dissolving government and getting rid of the whole Westminster system and starting from scratch. That may well be where this ends up, who knows. But the main thing is that those of us who are doing this kind of work and working together are looking for ways to use what we've already got to make it work better While other people think about redesigning the system.

Is that how you see it? Oh, absolutely. Uh, it's interesting. Uh, over my journeys, uh, talks, et cetera, I came across people from different groups are all on the same page and, um, they have their own particular. Aspects of our society that they wanted to tackle. But everyone, every person who, uh, was aware of what's going on with the who and the pandemic, uh, arrangement treaty slash the international health regulations, they realize the gravity of the situation and the situation is really simple.

We are, I believe personally, we're in a coup because we know from the the politicians. That, uh, Ralph Babette, Malcolm Roberts, et cetera. We know that this is going to be pushed through the Parliament and the average Australian citizen, let alone knowing that this is happening, have no idea of who the WHO, the World Health Organization even is.

And we have a situation where, uh, this, this pandemic treaty, and then the international health regulations are basically signing over the total management. Of health and Ted Ross, the leader of the who he himself alone can call and you're ready for this, a potential emergency or a potential pandemic. Now, what's that mean in one month, one year, whatever.

But in addition, Their scope extends way beyond that, it extends into the biosphere. So you're talking about plants, animals, the environment, and the magic word, climate change. So they will have power to make decisions on this, taken away. From, uh, us, the who are an unelected group and they're 85 percent funded by this public private partnership.

And what's that? Well, hello, hello. Uh, it's a big farm and multi nationals and Bill Gates. And they're on the the directing board and they have formulated this concoction of rules which basically is if you want a better term for the poor old Victorians, it's a Victoria Dan Andrews on steroids. And basically, I mean, very simply, it's it's too long to go into, but you know, we're going back to the day of forceful.

mandates, lockdowns, digital ID, misinformation, disinformation, and I'll just, just to throw in a nice, wonderful thing, we'll get rid of the old scientific method, which we did with the, the vaccines where the, you know, the, the vaccine studies would normally take seven to 10 years. These lunatics are saying that they can develop a medication in a hundred days.

Now, I don't know whether you've seen the whistleblower from Pfizer, but he was talking about, uh, a situation where when they decided to pass the five to 11 year old jabs in, uh, in the States, uh, the formula that they were going to give these kids was a totally different formula to the one that they were giving to the adults and had never been tested.

I mean, this is a sort of insanity and it extends through to, uh, countries. Developing their own biological, uh, genetic bioweapons. Um, and our government is going to sign us up to this and nobody knows about it. These are unelected people who will have no come back to, and we have to stop it. We have to exit the hood.

Wow. I mean, so many Australians are completely unaware of this. Even Tony Abbott said he hadn't really thoroughly read the documents yet. Yeah. But he just felt in the spirit of it, that it wasn't good for Australia. And I mean, you know, any people with influence in this government need to be well over this document.

And Katie, is there any indication that the, that the, um, the politicians actually know what they're about to sign up to? We had a chance to go to Canberra last year in August and delegation of amazing professors and doctors and lawyers went along to Canberra and we got to meet with a lot of politicians and none of them had a clue.

Absolutely didn't have a clue. And I know that they are. Busy very busy by design. Uh, those that had signed off on the last lot of amendments that, uh, were talked about in August last year, for example, didn't even realize that their committee had signed off on those amendments. So we've got even the ones that are holding the bag, don't even know that they're holding the bag.

So they have no clue. They. Do not know they take a template reply that they get given to them. They say, no, there's no loss of sovereignty and things like that. Oh, here's a fact check report or article that says, you know, there's no loss of sovereignty. Look, decision making for our public health response will be handed to the WHO.

They will be making decisions. Australia will be legally bound to them. Those decisions will pertain to lockdowns. Uh, masking, social distancing, travel restrictions, amounts of money that we will have to give developing nations to bring them up to speed. Uh, and that's just a small handful of what they can do.

The WHA will have full control of the process from start to finish. They'll be able to define, uh, or determine which is a, a pandemic of potential. Uh, they will control the research and development in a recent version of the document. They've just. Offered to regulate gain of function research. That's at the same time that they will be storing and hosting locations and laboratories where each country will be obliged to send in biological, uh, samples, uh, which have pandemic potential.

Now, can you just see what's going to go wrong there? Johnny. Well, look, I think this is all just part of a big jigsaw puzzle that's being put together at a very fast pace now. I mean, look at the other night, they're jamming through this, uh, digital ID, uh, legislation. I mean, that just signals, uh, very bad outcomes.

I mean, here we've got, uh, uh, this back of house stuff going on with these. These organizations that, uh, are sinister. There is no other way to say it. I mean, the people that are giving the advice in government, I mean,

they're doctors and whoever they are, but I mean, they'd be people that have never seen a patient since their residency.

Uh, there was some doctor that was arguing the other day with Gerard Renick in, in Senate Estimates. I mean, the bloke was a dope. Uh, he was trying to tell Gerard about, uh, all cause mortality and he was leaking it to this and it was all just, it was all just, uh, mirrors, smoke and mirrors. It's all it was, the whole lot.

I mean, and that's why I think it's important for people to understand that, uh, the experts that come on Club Grubbery. I've got skin in the game. I mean, it'd be really nice to hear, uh, Dr. Robbie Peterson's background because I know Dr. Robbie Peterson, isn't someone that's out, uh, you know, campaigning, uh, against the world health organization, uh, because he's got nothing else to do.

He's not someone that sat in Canberra, uh, pushing a pin. I mean, Robbie was a family doctor for 40 years. He's a trusted professional. He's someone that you'd go to, uh, you know, to save your life. Uh, that would pick up on problems, uh, and he's concerned. So, I mean, that should send off alarm bells in people's living rooms at home, uh, as to what's going on.

That's, that's your, that's your pup test. When people that, that are, you know, uh, are like Dr. Robbie Peterson that have been Good citizens, been a health professional all his life, just treated, uh, mums and dads and kids and family members and, and someone like that is getting upset. You have to ask yourself why?

Well, you, you touched on something really very important and that is, uh, uh, we're under the, uh, auspices of the TGA. And the TGA decide everything with regards to health in Australia. Now the TGA, would you believe it? A 95 percent funded by big pharma. Now, surely that's a contradiction in terms, but having said that, what we saw with the, uh, uh, emergency release of these experimental jabs, they accepted the fact that, uh, The Pfizer wasn't telling them the total components of the vaccine and I accepted that and we're prepared to give this experimental jab where they didn't know that that total 100 percent makeup of what was in it to the public.

Well, you know, as probably, well, the people in the, uh, uh, who are awake, you know, Kevin McKernan and, uh, Professor Buchholz in July of last year. expose these hidden ingredients. Hello, hello. Then number one thing was DNA, which, you know, is the very essence of your genetic makeup. And it was in all the vaccines.

And of course, that immediately made it the genetically modified organism, which meant that it needed to go through very stringent studies. probably between 7 and 10 years and yet it was hidden from the world and in addition, you know, you had other other little goodies like the what the lipid nanoparticle covered did and it's dissemination throughout the body and then you had this thing SV 40 which was a monkey virus genetic sequence which in the past had been banned because it caused cancer.

I mean, so these are the people in control of this country's health. And what's happening if we sign up to the who the who will have the power over misinformation and disinformation. What does that mean? Well, it means that the science is their science and independent scientists as per McKernan and Buchholz who discovered what were in the, uh, in the vaccines.

You know, independent scientists, that'll be it. Their, their word is gospel. And it is frightening. The scientific method's just been totally thrown out the window.

Look, it's absolute, it's absolutely staggering. Now, um, still people are not waking up to this. Still people, like I was at, uh, Manuri Pantry in Cuyahoga today, which John and I know about, uh, and frequent, uh, whenever we can. Um, and people there are saying, look, This has got so intense we're all switching off because it's just doing our head in.

Um, we can't afford to do that, Katie. No, we really can't. And those that are awake, um, I do appreciate that there is a huge amount of exhaustion. Uh, you know, you guys have been going now for four years. I've certainly been going for four years. Dr. Peterson, I'm sure you've been going for longer than four years.

Um, given that you were so intimately involved as a doctor. Uh, but, you know, We do have to take a break. We're all running on our sympathetic nervous system. We do feel frustrated that, you know, people, these things are coming at us and they're coming at us from all levels and all angles. Essentially we're in a barrel and the water's coming in every way possible.

Uh, but we do need to rest up. We do need to share the load. We do need to appreciate that sometimes we need to pass the baton on to others, but we can't. Uh, switch off entirely because that's not going to get anybody anywhere. Uh, and so, uh, we are all about communicating and getting these messages out to other people.

Uh, if we can share the load, then we certainly will share the load. Uh, we've got some amazing projects coming up, um, very shortly, uh, on a massive campaign that we are launching in order to get Australia to reject the WHO pandemic treaties. And that's really exciting. We actually just had a meeting, um, just before we came on and we're about to launch Australia's Biggest letterbox drop, which will be sending a flyer, uh, and at least 2 million letterboxes, which we've learned today is a fifth of the letterboxes in Australia.

And we will get that done. And I am super excited and anyone can, uh, deliver the flyers. We've got a very snazzy computer system that will allow you to put a dot on the place where you want to deliver flyers. We'll get those flyers to you, or you can print them yourself. And, uh, you know, Get outside, get some fresh air, look at the scenery and post some flyers.

And look at what John's wearing because Luke from Drifter has been printing these t shirts like crazy. I think it's his design. Do not comply, W H A U N W E F. And some of the guys that have been wearing them have been writing to Luke saying, you've got no idea the incredible conversations we're having in supermarket.

You know, check out aisles or in banks and stuff like that. People are looking and say, what are you talking about? One guy in particular was saying he just couldn't get out of the shopping center. Everyone was asking questions. So get on board at www. drifter. com. au and you can order those. And Luke will get them out to you.

And we need everybody wearing these t shirts. Excellent. Well, we'll get Luke's details as well. Um, because he clearly needs to be, um, part of Allied Council of Australia, um, especially with doing amazing work like that. Absolutely. And, and the Drifter brand should be on there. Should absolutely be on there.

So, um, yes, Robbie. Oh, hoodie. I was, I was just going to mention that, um, like these, the World Economic Forum and the WHO and the UN, they're all, you know, in the one basket, uh, the, uh, they announced their intentions. Uh, at Davos, the World Economic Forum meeting, which was what, three or four weeks ago, and Tedros got up and said, he said, the new world order will be triggered with the signing of the pandemic agreement.

You know, this is their one world government take over totalitarian, and he publicly stood up and said this. Yeah. They make no secret of it, do they? They definitely don't. These grubs are up to no good. I mean, look at this appointment of this, uh, governor general, this Samantha. I mean, she was at Davos.

Hello. Yeah, just on that, look, I think this is really important having been so involved with these WHO pandemic treaties, certainly in Australia and New Zealand, but also having appeared, um, in, uh, Before American and UK governments on these, I've really had the chance to meet some pretty incredible people.

Uh, and one of those, uh, people was a gentleman by the name of professor, professor Francis Boyle. Now he's the leading American human rights lawyer and professor of the international law at university of Illinois. I mean, he's written the books on international treaties and what he had to say about these documents was in his 50 years.

As a top international law and treaty expert, I have never seen an attempt by the global elite to create a totalitarian police state until now.

And the other thing, the other staggering thing too, uh, you're talking about the, uh, the WHO say in the treaty that they're going to regulate A gain of function. I thought gain of function was outlawed. Yeah. Well, clearly it won't be. I think that it was supposed to be outlawed, but of course they brought it back and then they were doing their, uh, sneaky, um, payments and continued research in China, which didn't have quite the same regulations and lo and behold, and, That was the cause really of the last pandemic, so they're not prepared to stop, they're a law unto their own, they can't even follow their own rules now with getting us a copy of the International Health Regulation amendments four months in advance of when they are to be voted upon, so, you know, whatever rules exist, they're not going to follow them.

Well, and look, the reality is that once you give them the keys, that's it. We're buggered. And that's why the government needs to be very upfront. I mean, When you look at the voice, uh, the amount of money that was piled into that. And when you consider the, the ramifications of the voice in comparison to this nonsense, they, uh, not even on the same scale, I mean, I mean, this gives these grubs the power to lock everyone up and if you think it won't happen, uh, think again, because it has happened, they've had a trial.

And it didn't go too well, if you remember. So if you think it's all right to give these people the keys to the cupboard, uh, we're, we're in real trouble. Um, and anyone, uh, what, why is the government not advertising what they're doing? What, why do they do this stuff in the, in the dark of night, uh, without any fanfare because it's no good.

Yeah. What you're saying is, is. Uh, not only can they forcefully mandate you, but they can restrain you to give you a hundred day tested vaccine. I mean, this is like out of 1984. It is just, and we have to stand up. I equate to where we are and the fact that they, you know, that they're going to try and push this route.

We are in a state of play where, uh, after the bombing of, uh, Darwin in the second world war. The Japanese actually have invaded Darwin and North Queensland, and that's the state of play we're in now. And so, you know, what we're trying to do with, uh, the, uh, aligned council is to wake up Australians to, to become aware of the who, and to go and see what the implications of signing up to this, uh, is and then rising up and saying to parliamentarians, no, this is, you know, we're not handing control of this country to an unelected one world government.

And so, you know, and I mean, we need Australians to wake up now we are in a diabolical set of circumstances and this aligned council, I mean, it's been inspiring as Katie said in the last two months. The number of people that were out there and were fragmented are a wake up. And so that's how, why we're together.

Our mission is to wake up the rest of Australia. They're a noxious pest. I mean, these people are the equivalent of cane toads and they're on the march. Look, it's absolutely true. And you look at the photo once again behind, um, behind Katie and Albanese with that smirk on his face and Wong who's always got this perpetually, uh, supercilious grin on her face.

I mean, these people, these people were not mandated. By the election to go ahead and do this, if we're going to have, if we're going to have a referendum, you need to be asking the people whether they want you to give their sovereignty away to an unelected group like the, the World Health Organization, the UN.

That's what you need to be doing. And you need to be doing that urgently because on your head, be it Anthony Albanese. If this goes through on your head, be it. And you reckon Goff Whitlam's had to deal with a whole lot of stuff since, uh, everything went down the pipe on his reign. You know, I, I really hope that we, look, wouldn't you love to have Kerr back in the job again, Sir John Kerr, you know, everyone said, oh, he was a drunk, he didn't know what he was doing, he did the wrong thing, and he did the right thing, getting rid of Whitlam, and where, where's the backbone of these elected, not elected, but appointed representatives of the government, who, um, of the Queen, or, or the Royal, uh, of the Commonwealth, I should say, who, uh, who should be making sure that the Commonwealth Constitution is upheld.

And not given away. Well, we've seen because, uh, uh, you know, uh, it was only because of Ralph Babette's persistence that we're actually having an inquiry into the excess debts from 2021, uh, the year after the, the COVID, uh, 2022, 23. Persisted to actually have a look at the 15 percent and they blocked it, blocked it like they have blocked having a Royal Commission into the whole COVID fiasco.

And I believe throwing in, I mean, Katie hasn't mentioned this, but I certainly will. I mean, We've got a hero from New Zealand, Barry Young, who accumulated the data of the vaccine rollouts and the damage over there. And Barry, you know, released this, notified all the health officials and the MPs about these shocking statistics.

That he had come across and then he also, after having done that, he sent it around the world. Well, he got arrested and his trial is being postponed as is, I think, a Royal Commission into COVID as is the excess deaths. They don't want any of this information to come out before the May 27th, uh, World Health Organization.

Uh, vote, because once people are made aware of these sorts of facts, they'll be horrified. We need Julian Assange to be free, although he'll be, he'll be virtually wiped out mentally from everything he's been through. This guy needs to be set free, but we need journalists of that caliber to get into this stuff and really investigate it and throw this material out there.

Uh, let's face it, he's not, he's not in this incarcerated state that he's been in for 14 years. Uh, because he was lying. He wasn't lying. He's being locked up and treated that way and they're hoping he'll die in prison because he's been telling the truth. And it's all linked. It's all inextricably linked to everything we're talking about here today.

Well, I think too, Woody, what we've gotta see is we've gotta see politicians being upfront about whether they've been to these WHO organizations, whether they've, you know, like, like the Sarah Hanson Young and Greg Hunt, you know, they're, they're part of the World Economic Forum Young Leaders Program that is a conflict of interest, uh, if you've gotta declare a bottle of wine or a box of chocolate's being given, I'm sorry.

I don't know how that's not a conflict of interest. If you've been on, on the, on the purse of these people in whatever respect Uh, whether it be, uh, uh, you know, uh, sponsored through one of these programs, that has to be notified in your conflict of interest declaration, surely. Well, in my mind, that being, being a WEF, um, young leader.

If we look at the WEF for what it is, it's a toxic waste dump. It's a toxic disease. Then you've been infected and you're spreading the virus of the WEF through the governments of the world and through the Australian government, in particular, Sarah Hanson Young and Greg Hunt, who's no longer here, but off cushing it somewhere else doing some other amazing thing.

You know, these people and people like Jane Halton need to be called out. Um, enough is enough. And so that's why it's important that the aligned council of Australia gets your support, get behind it, get involved in the things that they're organizing, because time is running out and it's, you know, it's too late when the, when the horses bowled it, it's too late.

We've got to hold this thing in control. I think the average person wouldn't have recognized this, but of course I did. And that was during the COVID pandemic. Uh, every second night, either the minister of health or the health leader of each state slipped in the word, the new world order. And so they were talking about it in the middle of COVID, the new world order.

And if you're able to go back and look at footages of footage, uh, you'll be staggered how often that word came out of the lips of those two groups of people. Katie, you and another team of lawyers with Julian Gillespie have been involved in another action against Pfizer about genetically modified organisms and they're not having a license for it.

And I believe the story is they have actually admitted that they haven't had a license for it. Now, where is that case? What's happened and what can you tell us about that? Sure. So in, uh, July of last year on behalf of Dr. Fi, uh, we filed a case against Pfizer and Moderna alleging that the MRNA, uh, vaccines were genetically modified organisms, uh, as per the definition in the legislation, and that required them to get a license.

Now we said, and when we were working up this case originally, uh, it was the MRNA complex, which satisfied the definition of genetically modified organism. But while working up that case along comes Kevin McKernan, who really unpacks the ingredients of what's in these Pfizer and Moderna shots. And lo and behold, he discovers the DNA contamination, which should never have been in the products, because.

They had essentially changed the process of manufacture in order to scale up the supply needed to Vaccinate the 10 billion people or so in the world, uh, that they needed to, or the doses that they had to. So we had a situation where that DNA should have been filtered out and it wasn't, and consequently the DNA then gets encapsulated in the lipid nanoparticles, which are the transport system straight into the body, straight into the cells, and are integrating into people's DNA.

So we took that case and we took that case to the federal court and, uh, we alleged, uh, alleged that Dr. Julian Fidge was any aggrieved person for the purposes of the act. And we asked the federal court to issue an injunction against Pfizer and Moderna for failing, uh, for dealing with their, uh, products without the necessary license for a GMO.

Context wise, AstraZeneca applied for and obtained a license for their product. Uh, which is a GMO. Pfizer and Moderna, uh, say that their products are not, uh, GMOs because they're not organisms. Uh, but they clearly are. They're a new biological entity. They satisfy that definition under the TGA application forms.

And, uh, you know, it's satisfying and ticking all the boxes of all the definitions for us to have, uh, to say that they are genetically modified organisms. So, heading along to court, and, uh, we had an argument in October last year, and, uh, Pfizer and Moderna applied to dismiss, uh, Dr. Fidger's, uh, application for an injunction on the basis that he wasn't any engraved person.

And, uh, Justice Rofe upheld that, upheld that decision, uh, in, uh, uh, October. March of this year, uh, and she made a finding that he wasn't an aggrieved person and consequently his case was summarily dismissed. Uh, the outcome of the case, uh, is really disappointing. You'll recall that we were involved in the AVN case, which was, uh, the mandamus application.

Uh, And that too was dismissed on the grounds of standing. And likewise, the Australian babies case was dismissed from the High Court and sent back to the Federal Court. So we've got very much a, um, I guess a playbook, uh, and we've had a situation where now Justice Roe for the Federal Court has handed down that decision.

When we were, uh, Looking a bit closer at the decision, uh, we uncovered some rather interesting and concerning, uh, uh, pieces of information. Uh, first, Justice Roeford actually acted for Pfizer as a lawyer, uh, um, and barrister for quite some time. And she had appeared as their barrister on at least five cases that were reported.

Pfizer was also mentioned in Justice Rofe's, uh, welcoming speech as a judge to the, um, federal court. So, uh, it clearly had significance. But it doesn't stop there. Justice Rofe appears to hail from, um, not just, uh, close working ties with large pharmaceutical, uh, companies in, uh, Australia. Uh, she also has familial ties, uh, with, uh, the pharma dynasty that exists here in Australia.

There are basic rules that we all have and we were just talking about people being obliged to disclose a bottle of wine when it comes to potential conflicts. Each day, uh, and each time we get a new client as a lawyer, we have to consider whether or not that new client might have a conflict with somebody we've done work for in the past.

And even if it's got the remote whiff of a conflict, we will let that client know so that they can make the decision whether or not to maintain the instruction with us as their lawyer. Every case that I have been on Where there has been a whiff of a conflict, the judge at the beginning and at the first opportunity has explained that they have a conflict, that they have had a previous relationship, or they may have done work for somebody, or they may have a distant relation, or perhaps they were even at a dinner party where someone was.

That isn't just a courtesy, that is an obligation, and we weren't even provided that information. Uh, which we should have been. So we could have assessed then whether or not it was suitable, uh, for Justice Roeff to maintain, uh, the decision making role in this case, or whether or not she should have, uh, stepped down and allowed one of the other 16 federal court judges at the Melbourne Registry to have heard this matter.

It's Uh, very, look, it doesn't sit well with a lot of people, uh, we've raised a complaint to the court, uh, outlining these, uh, things, and you're most welcome to see, uh, the extent of which and what the complaint covers. Uh, and we've also raised that complaint with every single one of the, uh, Parliament, sorry, members of Parliament and the senators, uh, because there is a possibility and likelihood that Justice Rofe should no longer be sitting as a judge.

And in that case, section 72 of the constitution is able to be, uh, relied upon and both houses of Parliament can seek that, uh, you know, she no longer holds that, uh, Position as a judge. It's we're in uncharted territory. I think you'll recall probably the Murphy Judge Murphy case back in. I think it was perhaps the 90s.

This is, you know, we're wandering into areas where, you know, it is unprecedented precedented. It's I don't. Yeah. I don't know. The complaint has been lodged, uh, as has, uh, an appeal in order to preserve Dr. Fidger's position, but we really are in incredible territory. Absolutely incredible. Gee, John, you'd imagine that the, this judge should have been disqualified by her own admission.

She should have disqualified herself. Well, look, if you were basing it on even a perception, uh, hoodie, I mean, I, who are we to tell these people what to do, but I, you know, look. At the end of the day, it's not a good look, is it, uh, regardless of, uh, what the outcome is here, uh, you know, in a time when people are very touchy about, um, the judicial system, because we've been in, in a fog where there doesn't seem to have been much, uh, positivity.

From the judicial system that just seems to burn a Holly, but negativity. I mean, that's now. Showing it up for what it is. Uh, there is so much data. I mean, there's been a, uh, um, what I would call a suppression of, of experts being able to give evidence. People have been disregarded as experts when they're clearly experts in favor of people that, in my opinion, are very weak when it comes to expertise, uh, people that have got, uh, runs on the board.

They've treated patients. They're not academics that sat in some. University, uh, collecting, uh, grants from the government. I mean, the whole thing's very, very painted in my, my view. Um, and, and I suppose, uh, we'll have to wait and see. I mean, I, I did ask, uh, Tony Abbott this morning, uh, what he didn't know whether He felt that the judiciary had become politicized.

I mean, we've got, uh, Justice Beach Jones, who was the chief justice in common law in the Supreme court, uh, that was in charge of the Kassam matter, uh, with Tony Nicolet, uh, Kassam v Hazard. Now he was then promoted to the high court. Um, he's been giving speeches to the university at New South Wales on the virtues of MRNA.

In fact, he's written a forward in a book, uh, in that regard. Now, how can this guy sit on the high court, uh, and not disqualify himself from any future, uh, vaccine case. And, and, and surely these things are going to find their way there. They have to, I mean, because. Every step up until the high court, we don't seem to be getting, uh, any, any traction at all.

We were getting, uh, this sort of thing occur, um, repeatedly and it's, it's, it's not right. Um, so, you know, they, they have to, um, There has to be a review at a parliamentary level, I think, as to, as to what's going on. And I'd be interested to see how many of those politicians actually responded to you, Katie.

Well, it's pretty, they have to respond when you call every single one of them and make sure that they did get the letter. And if they haven't seen it yet, then please print it out and read it. You know, we went down that road, John, where we, we emailed a three minute video clip urging Parliamentarians to, uh, to have a look at what we were presenting and we didn't even get one reply.

Not one. No, you definitely have to phone afterwards and make sure that they've got it. Otherwise it just gets lost in the ether. Now, as we're talking about health, of course, and you're a doctor, Robbie, with 40 years of experience. Um, cardiologists are telling us that they've never been busier as our funeral directors.

I've had a call the other day from a funeral director, excuse me, a funeral director who, uh, who was working for a funeral director, uh, when the pandemic came, he was, um, he was mandated out of the job and, uh, two years on, he decided to start his own business. And he said he is flat out and all the people in the industry are just flat out.

They can't deal with it. What is going on with people's hearts? What's the latest? Well, as I said, the, the, uh, there's been a number of trials that have said that one in 35 people have got clear cut evidence of, you know, sorry, one in 35 people have had a degree of myocarditis and of that percentage, one in 35, the trials are showing somewhere between 30 and 50%.

when they have the MRI and the next extensive test, uh, have got evidence of scar tissue. Now, what that means is that with the passage of time, depending on where the scar tissue is located, you may have a situation like we've seen. Well, I think there's 1400, uh, uh, well, this is going back some time with 1400, uh, supreme athletes, you know, uh, soccer players, basketballers, et cetera, and you, uh, in Europe who've just gone down for the count having, you know, cardiac arrests, young fit men and women, um, and with regards to the long term, well, if you're unlucky enough to, to have a situation where it involves the electrical system of your heart or later on in life, where you can't build new heart muscle and there's going to be a percentage of these people are going to drift into heart failure.

Um, and we're going to see increasing stories, which we've already seen, of, uh, young middle aged people going down for the count. Now that's, that's just with regards to the heart. The big thing is, which is, you know, we're all starting to hear, but of course in Australia we're censored so much. Is the significant increase in cancers around the world and we know the basis behind it, you know, uh, with what was discovered last July through McKernan the scientists subsequently.

And they're talking about these turbo cancers where, you know, sadly people have been in remission for many, many years. Uh, after they had the Jabs, the Jabs. They had a flare up of their cancers and not only did they have a flare up of their cancers, they died very quickly. And we're going to hear more and more and more over the next 12, 18 months, whatever, of this happening.

I mean, these things, uh, the data's there, they know it, they should immediately have been withdrawn last July after McKernan and Buchholz revealed what they revealed. And the stats right around the world have confirmed it. Barry Young from New Zealand. This is frightening. He came up with one in a thousand people who got a Pfizer jab died.

One in a thousand. Now that's been hidden under the rug. But interestingly enough, from a statistical point of view, and the gurus of statistics around the world, have confirmed that this equates to this common 15 percent increase in excess mortality. It's amazing how mathematically it aligns up with it, but there's nothing to see here as we're finding out with the fact that the vast majority of people haven't even heard of the whistleblower, Barry Young and his New Zealand data.

And that's, you know, they pulled the wool over our eyes and, you know, we have to fight, we have to stop this. And as I said, the who are going to mandate 100 day tested poisons. I mean, it's a nightmare. Yeah, but let's not, let's not go overboard. This is not jab related. This is long COVID isn't it? Well, it's interesting you say that because they they actually have a test which can differentiate between Uh, somebody that's had, uh, issues with, uh, the jabs and non, but of course, you know, that's not available and that's kept under the carpet, but it's seemingly that the very large percentage of people with so called long COVID, in fact, it's long vaccination jabs.

I mean, the statistics. They, they pulled these stats down going back to March, 2022, uh, in England. They, they were doing, uh, a weekly assessment of, uh, uh, people. hospitalized with COVID and they were correlating it with the number of jabs they had. And interestingly enough, in New South Wales, uh, later in 2022, they were releasing the same figures, but what the figures ended up showing was that it was like a premiership ladder.

You know, people who'd had the most, which in England at that stage, it was four were representative of the highest number of hospitalized followed by three, two, one, and the unvaccinated were less than 1%. Well, in the New South Wales figures, which of course they pulled down after people like myself woke up to it, you know, their, their record showed that zero people who are unvaxxed were being hospitalized with COVID and the same thing.

The majority of people, the highest number of people had had the most jabs. There's your statistics. What more do you need? And it's, uh, but now they've all been pulled away. So the average person, they're no longer available. There was four, four, uh, jabs, uh, in that fortnight, 810 people in hospital, 58 were in intensive care that had had four or more jabs.

There was zero people in hospital that had been, uh, jabbed. So I mean, in that fortnight up to December, so that's why they pulled the data. Uh, it just went exponentially through the roof as you had more vaccines. And I mean, you said that had been jabbed, John, you mean that hadn't been jabbed? Those that had been jabbed, so if you'd had four jabs.

Or more. There was 810 in hospital in New South Wales, 58 of them in intensive care and zero people, uh, in hospital that, um, that, uh, were unvaccinated zero. Um, and just to confirm what, uh, Dr. Dr. Rob was saying, there are, um, I mean, I, I've got a, uh, a note here from a family practice in, um, in, I think it's New Jersey, uh, overseas student athletes.

Uh, and so this is from Dr. Anthony J Luca Tonto. So it's a student athlete sports. Physicals are done primarily to make sure you are not at high risk for sudden cardiac death on the playing field. COVID vaccinations affect your risk in response to worldwide experience and vaccine adverse event monitoring.

We are adopting a more precautionary sports physical sign off policy. If you have received doses of any COVID vaccine, we will not be able to clear you to complete. To compete in sports without performing lab work and possibly an ECG to rule out potential heart damage. I mean, this is students at universities just want to go and play, uh, football or softball or whatever they play over there.

Uh, I mean, speaks volumes, doesn't it? You're not hearing about it. And I was contacted the other day by a designated aviation medical examiner, uh, of, uh, some repute. He does a lot of aviation medicals and I won't go any further than that because I want to protect him, but. Uh, he says that the, the lack of research and understanding of these serums that have been forced into pilots is breathtaking.

He said it's been absolutely catastrophic. The uh, the lack of understanding he's, you know, uh, there've been conversations with Casa Medical about, have you done this? Have you done that? No, that's not our job. That's not our job. So there are pilots flying around who are telling me because they, they talk to me from within the industry.

That they are flying with a heart that they know is not well, but they're too scared to mention it to anybody because they don't want to lose their jobs. And I'm not, I'm not telling you porkies, that is absolutely how it is. So a lot of them are saying to me, we wish we'd followed what you'd done and hadn't got it.

We did it to save our careers. In actual fact, we may end up losing our careers and we're worried we're going to lose our life. Now, this has got to stop. This has got to stop. So I guess, look, we're running out of time. Um, we probably need to get this one edited, but, um, where to from here for you, Katie? Uh, well, I can assure you that I don't intend to stop, uh, the WHO and, uh, these mRNA products are, uh, what's in my crosshairs and I will be ensuring that, uh, I tell as many people as possible about all of these issues.

It's just such a shame that so many people have been hurt. Uh, I really do believe that unfortunately out of that unfortunate situation that people Have be prepared to say no next time. But what's happened over the last four years is about to happen on steroids. And if these WHO pandemic treaties get up and the ability to say no will be harder.

That's why it is so important for us all to say no, no now that these pandemic treaties must be rejected by Australia in May 2024. And we just can't allow the last four years of tyranny to occur again. Absolutely. And your website is www. alignedcouncilaustralia. com. au and everybody jump on board there, have a look, get involved, tell the people out there what's going on, grab the t shirt that Johnny's wearing, I've got mine on the way, and we need to wear that with pride because it really is causing quite a bit of a stir in the community.

And, uh, Robbie. Where to from here for you, mate, because you're ahead of this. Oh, look, there's only one way I, you know, uh, a hundred thousand Australians gave their life over the journey, fighting for freedom in this country. And, you know, we've got plenty of examples of the bravery, you know, the guys in to book Dakota and long tan.

And, you know, these people gave their lives fighting for freedom. There's no way in that. I'm going to stop. This country, as I said, A coup where this parliament is going to sign away control of this country to unelected people and it's a totalitarian world where they're going to inject poisons into us and I can't stop and you know I believe there's enough Australians out there once they've woken up we can stop this I really do if we don't the next future generations You know, it's, it's going to be a nightmare and none of us, none of us can have our grandkids say, why didn't you do something?

You know, this is it. We're, we're, we're in the fight of our lives here and people have to wake up and understand the gravity of the situation. Well, we've said it before a million times. If you're not part of the solution, you're part of the problem. So that's what we've got to get into. Um, any final comment, Jonny, before I pray it out?

Uh, nah, I'd just like to thank the guys for, uh, For being in the fight and, uh, yeah, I know, uh, it's, it's difficult for everyone, but, uh, all of you out there, you just need to spread these messages. I mean, that, that's the component that you, you can assist with, uh, if you feel you can't do anything or you, you, you, you, you don't know what to do to share this, um, buy a t shirt, um, talk to people at your local news agent, shopping center, doesn't matter, just, just engage in conversation, get people critically thinking.

Yeah, be brave. It's look, you'd be surprised how many people are gonna, you're gonna wake up because I see it all the time, all the time. Uh, even, even today, as we sat at lunch. At the Manurey Pantry in Kyogle. It was, I gotta tell you, the best salmon I've ever eaten in my life and I bought it, they didn't give it to me, but I tell you what, and they're making up another tray of Larder's Balls.

Put on sale, Johnny, in honor of you. Uh, and they're gonna send you the recipe so that you can make them for the cafe that you're running. But, um, yeah, thanks to Tinky and, and, uh, Brendan for that. But the people in that cafe, they congregate in places like that. In towns all over Australia where they know they can go and relax and talk about these issues and it's great to be recognized when you go to these places and people come up and tell you their stories.

So, this is how we affect change in this country. There's no doubt about it and we're not going anywhere. Um, what grubby is going to be around for a while yet, Johnny, unless they bring in a misinformation bill, then we might be in trouble, but I don't know how they can bring in a misinformation bill because most everybody on the planet gave misinformed consent to this vaccine.

There's no way anyone could have given informed consent because there was no information. It was kept from us. And we're going to say it again. Conspiracy theories thrive when governments keep secrets. If the government's not going to be transparent and share with the people what they're doing behind the scenes and stop rushing through midnight legislation, then you're going to be subject to conspiracy theories because nobody trusts you.

And that's the big pandemic in the world at the moment is a lack of faith and trust. So on that note, allow me to pray this one out. Dear Lord, father in heaven, we just thank you for the ability to talk across miles, to discuss truth and to discuss urgency.
