

2024-05-08 Graham and John speak with Nick Patterson and the outcomes from his legal outcomes...

G'day

everyone, Wednesday the 8th of May, and it's great to be back with you on Club Grubbery. The response to Julian Gillespie, John, is going through the roof. Um, what a courageous, uh, effort that was on behalf of the, uh, former barrister. Yeah, well, Woody, it's sort of just. Demonstrates, doesn't it? Just how we can't rely on the judicial system now.

And, uh, it's a dreadful circumstance we find ourselves in. And, uh, the only way to sort of get the truth and, uh, honesty out of the people is through mediums like this. Absolutely. And we've got to keep going and we're really pleased to be joined tonight by our mate, Nick Patterson, who has been on the program before.

A real tough fighter and boy, has he been winning a couple of rounds. Good to have you on Nick. Thanks guys. I appreciate being here with you. Yeah, you've been doing the rounds all right, mate, and you seem to be, uh, you seem to be picking up a belt here and there. What's happening? Yeah, well, I just had a big win against the, I had my third win against, um, the corrupt police during the COVID madness.

Cause when you stand up to the false narratives and you speak out and you have a platform, which I used to have a platform, you become public enemy. Number one. Uh, so I was arrested and dragged through the courts for four different issues to do with, you know, keeping my gym open, um, and, uh, and a couple of rallies and so far I've.

I've beaten the big one and two other ones. So we've had three wins out of three cases so far, which just goes to prove that you can beat them. Um, if you, um, if you do it the right way and if you walk with God and walk in the truth, and I always applied that biblical principle, he who endures to the end, shall we say, which is where you get the maximum of law.

He who leaves the battlefield first loses by default. And because I'm always looking to Jesus and I'm always looking to God and I'm always saying, this is, this is what. What's right and true. Um, I, I never lost any confidence to keep going, even when, you know, the, the legal bills were amounting into the hundreds of thousands of dollars, which is money I don't have.

Uh, but I've had a lot of help from a lot of friends. A lot of my close mates have kicked in to help me. So we've learned a lot. And in, in this particular ruling, cause there's a lot of, a lot of COVID cases for where police assaulted people. Individuals, they never went to trial or even a pre trial or they're in the magistrate's court, which means there's no precedent.

But we had a five day pre trial hearing for, um, the, the, this was a case going back to 20, 2021, when, um, we were basically bashed by police and I was put in jail for 29 days and I had my shoulder broken. And of course I was, Because I was the, the ringleader of the group, uh, and the one speaking out, the police deliberately targeted me.

But we had a good ruling in, in our five day pre trial hearing, which ended up, it's, it's actually been, um, it's, it's now live, You know, online, you can, you can read it. It's been published on Ausley and, um, and I might take you through that if you, if you, if you'll let me, but there's a few, there's a few points that are really specific that could help a lot of people who may have, um, matters against corrupt place, especially tactical place during rallies.

Uh, but yeah, ultimately we've got a big win and this is now the, the third big win against them. And I've just got one more, a smaller one to go now. How have they reacted to their loss? Well, it's, it's actually incredible to me

to understand the psychology. Now you have these police officers who must just think they're so, they're so sure of themselves.

They have so much power. They can do whatever they want. I've even had to please say to me when they've harassed my wife. At home like that, you know, that actually, cause they came to my house, um, consistently in the middle of the night just to check in on me because I was going to rallies and organizing rallies.

Um, and they harassed my wife one on one, one particular evening. And they said to her, we can do whatever we want, mate. And he really arrogantly. And I realized that a lot of these police officers, because just so you know, there's seven ex police officers that have been working with me on my case.

Actually, eight now. It's an eighth one. Um, who are working with me on my, my case, my big one that I just had. Uh, and now the next one as well. The last, the last installment of our, um, of our COVID, um, COVID cases. And. You know, they're, they're ashamed of the way police have acted and it's clear that the culture in the police force is just rotten.

It's rotten from the head down because when you've got 43 police witnesses who are aware of what's happened, that police have literally stalked these people, uh, attack them and then lied. And said that we, we assaulted there when they actually assaulted our mate and we went into defending, uh, but they'd no mention of them hitting and bashing up our mate.

And then you would think that there'd be at least one decent police officer who was there who would say, nah, not doing this. And not one of them did. When we were in the pre trial hearing, we had the court filled with our people every day. And. You could see there was the informant with one of her off siders, um, sitting at the front, in the front row.

She kept looking back at us, pulling all sorts of faces, and it was obvious that she really didn't have any remorse, um, for what she had done and what she's a part of. And the kind of, and I'm just, I would just assume that they've been involved in, in hurting a lot of people. We were just six out of many.

I'm sure that there were many other people that were assaulted by the tactical police. So yeah, so in the, in this ruling, and it's interesting because we've had, this is in the county court, we've had three judges and now three prosecutors in this case as well. Cause once we'd get close to trial, we would just lose the judge and would lose the prosecutor.

And then we would have to start all over again. And this I'm sure is, is a tactic to drag it out, uh, to make it more costly. And anyway, I am, um, I'm pretty sure because the, the judge was conflicted against us, because there's two of us that were in this case. Everybody else had had their charges dropped right at the last minute.

They were offered plea bargains, which is where they say, look, we will remove all of these charges. If you plead guilty to these lesser charges, even though you've done nothing. You've just been bashed by the police, but that this is the standard operating procedure and I've had police tell me that that's what that's what corrupt police do.

They would just stack you with all these charges. And it's more of a psychological thing where they just get in your head and hey we can put you in jail, you've got, you know, you might go to jail for two, three years. All of the charges I was charged with, I could have been in jail for, you know, more than 15 years, right?

If I was to be found guilty of any of, uh, of, of all of them, but I wouldn't have been because the, the evidence just wasn't there. But a lot of people don't know, don't know that, and they don't have the confidence. So they will often make a plea just to make it all go away so they don't have to go through the courts anymore.

But none of our guys did that. Uh, but there was, in the end, there was two of it still going through the courts and we were in the same trial, or we'll, we were in the same, in the, yeah, same trial. Uh, we had, we didn't actually

go to trial. We got to the pre trial. So, um, where was I going with it? Uh, yeah, so we had, yeah, so I'm, I'm convinced that the judge from seeing 43 police witnesses say, say it happened a certain way, this incident, and many of them saying that we were violent towards the police.

Um, and obviously looking at my. My, um, like the briefing from the police that I'm, I was a professional MMA fighter. I trained fighters, uh, and, and I, I look like a fighter. I've got cauliflower ears. I've got a flat boxer's nose. I reckon she just believed the, um, what the police were saying until she saw the footage in open court and she completely changed.

She was completely biased towards them in my opinion. And then she completely changed. She, she turned the corner and she was calling out the police for their, for their lying and their statements. She was calling them out for the assault against our, uh, my mate, Jason Reeves. He was the guy that the police ran across the road first and started bashing.

Uh, and she also noted that the police were using force and assaulting us. Before we even got to that final, that final incident and it was, it was agitation and the, what we did in the pre trial was we did two things. We ran a collateral challenge to the lockdowns, um, in which we had, um, the judge confirmed that we needed, uh, that, that the prosecution were required to provide affidavits from Brett Sutton.

It was the chief health officer, uh, and Ginny Makakov, the health minister to provide all of the scientific evidence to establish the lockdowns, but then she changed it soon and said, well, no, they don't really need to provide. All of the scientific evidence just to prove that they met the legalities, you know, that they did everything they were required to do.

So we were pushing for that, but at the same time, I thought, well, we'll run this, this, um, application to have the evidence removed, which is all of the evidence, which actually favors us and our claim, um, in our case, but if you remove all the evidence. Then they don't, the prosecution can't prosecute us. So we ran these, these two applications and the application that she granted us was, was the evidence to be removed or deemed as inadmissible because the police committed a violent assault for the purposes of inciting a reaction.

And that's what she says. That's what the judgment essentially says is it's like if the police bash someone to get a confession, that confession can't be, it won't be admissible in the court. And she agreed that the police did incite, um, our re a reaction from us because the police had received and actually put together a briefing for the protest day where we were assaulted.

And it had like pages and pages about me in there. Being the leader of the peacemakers, which happens to be a ministry. Um, and then I was an MMA fighter, which happened to be where I do most of my ministry work in the gym. And, uh, that it said in this briefing that I would, um, use force if I believed that I was being unfairly treated or members of our group were being unfairly treated.

And so they can't say that their use of force was, was, um, well, they, they can't say that they were shocked at how we reacted when they started just bashing our mate because they knew that's exactly how we would react. If, if you're bashing our mate and he's done nothing wrong, we're going to run in and we're going to have a scrap with you because we have the right to defend him and protect him.

So, um, so all of the evidence was deemed inadmissible, which means all the body camera footage, including their own statements, which means they have no case. They can't prosecute you without evidence. So that's the win that I received on that, you know, on that, in that pre trial. So that's, that's really big.

And it's, it's very, very interesting. Um, when you read through this, this short, this short ruling. Um, how she, just how she calls out that the police, the, the, the use of incitement. They're, they're, um, basically she calls them out for lying, um, with, in different words for, for their statements. Uh, and that they, um, they used excessive force and, and they assaulted our mate Jason Reeves who was on his way home trying to get home

because we were told to leave the area and we did, we're on our way home and we were stalked, harassed and then bashed by the police.

And then when we, um, when we were, um, we, we had that, that fight with, uh, There's probably about 30 police officers and six of us, and you know, we were capsicum sprayed and they, they were using the batons as well. Uh, they didn't put anybody in jail. They just put me in jail. And when they bailed all of us.

They only bailed me with the conditions, um, with the, with the gag order. I couldn't speak. So it was, so it was targeted. It was specific bar conditions only for me and putting me in jail and not to anyone else. We all, we all went in and ended up trying to, you know, find with the place to defend our money.

But only one of us was treated that way. And I was the only one that had my shoulder broken. So it was deliberate. Like they deliberately targeted me and it, and We've gotten many times on their own audio from the body camera footage, where they're actually pointing me out saying that's Nick Patterson.

Let's get him. He's the gym owner. He's the guy that owns a gym. He's the guy with the cauliflower ears. So they knew who I was and they obviously, because when you speak the truth, you start, or will you do something like, let's say, keep your gym open and have interactions with the police. And, and, and the police and you, you speak the truth in a way that people resonate with people and those videos go viral.

Cause those original videos where I had police come to my gym, they had, one of them had like 11 million views right at the beginning of the first lockdowns. You become an enemy to the, um, to the ruling, the ruling class, because they get their power from their ability to perpetuate the law. Perpetuate a lie like climate change.

You know, that's one where they, they really, you know, that's a great big stronghold of power based on a lie. So when you speak out against that lie, you're, you become the enemy of their, of their power, same thing with COVID, same thing with any of these, you know, when you start speaking out against how they're pushing all this racism, you know, and all this ideological stuff to get us divided.

When you start speaking out about that in a way where people are listening. And you're getting a, you're getting a platform. You'll, you'll find you'll get shadow banned on social media or kicked off social media. Um, and now they're bringing in obviously legislation to restrict their ability to speak. So you can see what's happening.

Um, and, and I can see why, but what it does is it confirms that our ability to speak is our greatest weapon that we have, because that's the way you break down the narrative. That's the way you, and which is the way you take away their power and give it back to the people. I think our greatest weapon is our ability to speak.

Um, and obviously we were targeted. Because I was speaking out and organizing groups to run rallies and then they went after, um, our guys, but specifically me and put me in jail, broke my shoulder and then bailed me with a full gag order. Um, but finally, after three years of being dragged through the courts, um, I'm able to say, hey, we've got a win there and it's a very powerful win and the precedent in that case is very powerful for other people to use.

Wow. Johnny. Oh, it seems to be a pretty familiar theme, this, doesn't it? I mean, if we think back to, uh, Dr. Bruce Pei. Uh, once again, uh, I mean, he was another, uh, person that was victimized and without the assistance of, uh, video footage, uh, which he presented, uh, he, he probably would have been, uh, the victim of, uh, of bias, uh, within the judicial system.

I mean, the question's got to be asked, isn't it? What, what's happening to these police? that have lied. Where, where are they at? I mean, we've got a circumstance in New South Wales where the commissioner of police has found that 55 police were guilty of gross misconduct for failing to have the mRNA jab.

But here we have this, uh, continual, uh, uh, situation where police are lying in, in statements and presenting evidence at courts. And there's nothing to see here. Like what's happened to these people? Yeah. Good

question. Well, at this stage, so I've started putting together a civil case, but we're also, we'll be going after them criminally as well, and there's no statute of limitations on, on criminal offenses.

But there is a statute on, on, um, personal injuries claims. So I'm going to do that one first because that three year period's almost done. So we'll get that started. And then I've got a whole bunch of ex police, um, and, you know, and they're going to be helping me put together a brief of evidence to prosecute those, those, not every police officer, but the ones that are, um, you know, that were the worst in that situation, uh, because police need to go to jail.

And what you do is when you, when you, um, because what will probably happen is we'll, we'll lay charges on the police, then the OPP, the Office of Public Prosecution will probably try to take it over and if they offer up no evidence. We, we, we expose it and potentially arrest, you know, whichever agent from of the OPP um, seeks to do that.

For conspiracy to prefer the course of justice or, or, or preventing the course of justice. 'cause you've just gotta make it big. It's a big problem. Uh, and these people can't get away with it. Uh, and there's still a lot of things we can do, but it requires people, um, a bit like, you know, Julian Gillespie who are willing to go outta their way and, and put.

Put themselves in, in almost in harm's way, but for the principles of truth and justice, which I think is that's the Christian ethos right there is that you're, you're willing to sacrifice. Your, your, your willingness to sacrifice, you know, your, your, um, status and standing, your, um, your wealth, even your name, your good name, maybe a cushy job, whatever it is, is a testament to the value of the principle that you're willing to lose those things for.

Um, and I think the, um, there's a maxim of law for that inequity, which is, um, sacrifice, um, proves the measure of one's credibility. Because when you, when you, you make something, something becomes more credible when you're willing to, to die for it or to suffer for it, because if it wasn't a true principle, you wouldn't be willing to do those things in the first place.

It was a false idea or something that wasn't true. And I think what it also does, uh, Nick is, is it demonstrates what a spell COVID had on the media, what a stranglehold COVID and the pharmaceutical companies and everyone else had over the media, because. In, in any other media cycle, I mean, police brutality, uh, or misconduct with the videos that were, were floating around would have been a mainstream media news story, but there certainly wasn't any, uh, real presentation of what really occurred in your situation by the media, was there?

No, and then all of the other stuff that happened as well, there was, I mean, that was just one, one apex to it. There was, it was happening all the time. I had police at my gym all the time, police at my house all the time for what? Because I'm calling out COVID. You're a cooker. You're a cooker. And so the media, uh, weren't prepared to, to, to look at the real truth of what went on in your situation.

Because, you know, You were seen or you were portrayed as a nut bag that was out there causing trouble in relation to Covid? Yep. And, and just as well, I'm, I'm strong in my values and my principles that I don't care, you know, I think a lot of people care too much about what, you know, what others think. But at the end of the day, the truth is what matters the most.

And if I'm built on the, on the rock, I don't care. You know, and I expect, especially when you know that you're going to be attacked and persecuted and hated by many for that, but you're also loved by others, people that love the truth and understand what's going on and see it for what it is. It resonates with them and they get inspired and they say, yes, that's, that's true.

Which is why I was, I was helped so much by so many of my mates and even people I didn't know. Um, they would say, look, Nick, I just, I feel inspired to help you out and here's some money. I know you're doing it tough because I, I lost my jig. of 12 years. I had a successful business. It was a good business.

Um, I even had three, three homeless people living in that, in that gym. And we, we, we ran it as a ministry as well. And, you know, then they've all had to, had to find somewhere else to live and, you know, it affected us. Um, it was emotional. But at the end, I was happy to have it, uh, to end that chapter and go, all right, we need, I'm getting pushed in this other direction.

Uh, and like, you know, you, you feel if you're connected with God, you feel God pushing you in a certain direction. I thought it's time I've got to finish this now and focus on other things. Um, but you know, that, that was, that was something that we lost for, for the, um, for the truth, you know, because we were speaking, speaking the truth that most people now know, at least in part.

Um, you know, they know that. We were, we were lied to about these things, but because I was speaking all the way back then, at the very beginning, um, you know, we got a lot of, a lot of police attention, you know, and it's not nice when you get, it's not nice to have interaction with the police when they're violent.

It's even worse when the police come to your house. at one o'clock in the morning, midnight, with, and they just, and they're just there just to check in on you. And you'd say like, why, why are you here? What have I done? Oh, well, you, you, you're a person of interest. What do I do that's interesting? Oh, you attend rallies.

So you're here at midnight, one o'clock in the morning to, um, because I go to rallies. We even had 18 police cars turn up to my gym one, one night with, um, channel seven at the same time. And I filmed it. I've got all the film of it. Literally they turned up and it was interesting because I, I was running these meetings with gym owners and business owners at my gym when we were talking about how the human rights charter of Victoria couldn't have been suspended because it needs to be suspended in the, um, In the parliament with the declaration.

That's what the act says. And that never happened because parliament was shut. So I said, so I kept asking people, please, whoever else, like, you know, how can you, how can this human rights charter be suspended and our right to operate our businesses be suspended when you haven't done your due diligence and, and, and, you know, run this through the parliament.

Uh, and, and no one could answer the question. Well, if you can't answer that question, I'm going to keep my gym open. So I was, I was bringing people into the gym. to show them this, this research, which isn't my research. It's research from a good mate of mine, Darren and others. And we talked about this and this particular week, we were going to run this Saturday event.

And I thought, I reckon the police are going to come. So I, I had, cause I did everything publicly. A lot of gyms stayed open, but they did it on the down low and quietly. I wish they had have done it loud. When you do it loud, you inspire other people to do that. And it breaks the narrative down a lot faster.

I did it that way. I just, I don't care if they turn up, they turn up. I know I'm right. Um, but anyway, I was publicly on Facebook, um, announcing these events, these events at my gym. And about Wednesday, I remember the event was meant to be this particular one on Saturday. It was on the Wednesday. I had this, this inspiration inside that the police are coming.

I know they're coming. No one told me the police were coming, but I knew they were coming. So what I did is I did another post thinking the police are watching my posts. I knew they were though. I was having a lot of attention from the police anyway. So I did this, this, this second post saying, if you haven't been cleared by our security team to, um, to come to our event on Saturday, contact me first.

Now, we didn't have a security team, it was just me. Um, but, but people would ring up and they'd go, Hey, can I come? And if I knew them well, I'd say, Yep, yep, you can come, but we're going to do a Zoom and please don't tell anybody. Then other people would ring if I, and a lot of them are people I know now and I trust, but I didn't know them well enough to trust them.

So if there's any doubt, I'd say, Not, don't come, you can't come to this one, but maybe the next one. So anyway, we're doing this Zoom and we see, I'm, I'm live streaming the cameras from my gym while I'm doing this Zoom and we see Channel 7 and the police turn up, then more police cars and then there was just police cars everywhere at the front of my gym and it's a backstreet.

Two of the guys that were on our Zoom went for a drive, these are people that live in our area, so they were within their 5Ks and they, both of them counted 18 police cars. For what? Because we're, we're having a discussion about the law, 18 police cars, and they were there for hours, they were there all night, and then the mainstream media wrote up and reported that, uh, Lockheed had been shut down, and just rubbish, just lies.

So, um, so yeah, so this is all a testament of how powerful it is to when you speak the truth and how much power that has. And when we think these people have all of the power and they've got all the resources, all the algorithms, all the infrastructure, they really need that to beat us. If we could just work together.

And get over our differences and be honourable enough to go, you know, let's work together. Let's treat each other well and do it in the right spirit. We could completely destroy these guys. We can destroy their narratives and we can take over. Um, but we can't do that yet. We're not there yet. We're not, I don't think we're humble enough or make enough yet to be able to do that.

But what it, what it shows is that, you know, one guy and there was many others, but just, just my experience, um, in my situation, it's one guy speaking the truth, getting some influence, people are following, um, and, and they're standing up for themselves and when they stand up for themselves on those true principles and they're doing it well, other people see it.

Right. No, it's it's that it's that simple principle of let your light so shine. That, you know, before men, they may say good works and the light you're shining is, is courage and confidence and truth. And when people say it, they go, yeah, yeah, that's right. And that's, that's how you can invoke some more of that courage, which was lacking during those, um, Those lockdowns, which was a, which was a pretty awful time, but I look back at it now.

It's interesting how, when you go through a tough experience, you seem to forget all the bad stuff and just focus on the good stuff. And I think the amount of growth, you know, we would have all experienced is, is huge and it's well worth the struggle. I'm a much better guy than I was four years ago. I'm a much stronger person in myself as a result of this.

I think COVID was a. was the trauma that Australia had to go through to wake up to itself. I really believe that. And you've, you've, um, you've demonstrated that clearly. Um, and what you're saying is reference to Galatians 1. 10, for I speak to please God, not man, because if I speak to please man, how can I please God?

But the abuses that you suffered, the physical abuse, the intimidation, There's another layer of abuse on top of that as well, and that is that the people of the country have to have faith in their, in their law enforcement bodies. And people have been abused in that sense as well, institutionally abused because the police that they've grown to trust or learn to trust have become thugs overnight under, um, under Commissioner Patton.

And very interesting that they're wearing black shirts in the process. I mean, we're wearing black. As well. But, um, there's a very sinister feel about Victoria police at the moment. And a lot of the, the old timers in the Victoria police would be, would be really upset about that. Yeah. They've, they, even police that I know that have, that have, um, you know, they've been in there for a long time.

They're disgusted at what's happened to the police force. You know, they, um, like I, I had one of the, one of the guys that used to have keys to my gym was a police officer. Yeah. I think he's still a police officer now. Good guy. Really good guy. But just, you know, he's, in the end, you know, he said, he said, sent me the key back.

It's like he was ashamed of what the police had done to me. Sent me the key back to the gym with a letter saying, thank you for all the training. But I really, really trusted the police before. But after my experiences with them, and it's, it's not that I think these people are just evil, like they have this evil sinister ideology.

I think what it is, it's, it's the abdication of morals, which, which enables the evil, because I think most of them just don't think enough or care enough to do what's morally right. That's what it is. It's, it's a whole, like, almost like an army or a legion of people who are being directed by this authority figure, which is police command that they believe is evil.

It has the power to tell them who they should arrest and for what reason, but the reality is, no, your morals should come first. And when you can see, you can't switch that off. We should, as human beings, we should never, ever think it's okay to switch our emotions off and switch our, our feelings off and our conscience, which is exactly what's happened.

They become like robots. Actually, a mate of mine, he was a tactical police officer. Not anymore. He's left. He literally said, um, he, he said he was so disgusted at knowing that I went to jail for 29 days. Um, and he's, he's watched the footage. He said, it makes me sick. He said, they're not police, they're just robots.

That's his exact words. They're not police, they're robots. Um, and, and they did a good job of getting rid of the real police by, you know, by having, having these mandates that basically these mandates sidelined all the, the moral people it would. It would otherwise, you know, do the right thing. Most of them left.

And now we've lost 30 percent of our Victorian police, police force, 30%. I mean, that's a big chunk of the police force gone. And that would be the, that'd be the shining, shining lights in the police force. And they're gone. There's to be very few left now. I'm sure there are still some good ones. that are holding on there, they're enduring, um, but I don't think that's the majority at all.

Johnny, we've seen, uh, we've seen actions by police, especially in Victoria, committed by very junior officers that were just playing thuggery. It doesn't say, it doesn't speak much for the integrity of the, uh, of the recruitment procedures and policies in Victoria police, does it? Because, you know, that old lady that was pushed to the ground and then pepper sprayed by two young thugs who had their mask pulled down underneath their chin.

And I just emptied two cans of mace into a face. I mean, for goodness sake. Um, those guys, those guys were lucky to be, if they were 22 or 23. I mean, where's the leadership in the police force? Where are the sergeants who clipped these young fellas around the ears like they used to? Yeah. Well, Hooty, look, I don't think it's just the Victorian police.

I think the whole, uh, the whole regime across Australia needs a complete review. I mean, we, we we've spoken previously about, you know, Uh, and we've been knocked for it. I mean, I've suggested that there's apparently somebody in the training ranks in Goulburn that identifies as a tiger. Now people thought I was completely mad, but only last week, uh, it was front page of, of the Adelaide, uh, newspaper that there is a police officer there identifying as a furry or a pussy cat.

Now, I mean, get rid of all, all this white stuff. I, I, how, what's going on with the recruitment? I mean, that tells you everything, doesn't it? I mean, if you've got people that are coming in there and think they're tigers or pussycats, I mean, 10 years ago, I mean, they would have been treated, uh, as though they've got a mental illness.

I mean, what, what's changed? I mean, those people need help. I mean, they don't need to be, uh, you know, accepted as if there's something right. I mean, that's not normal, is it? Or am I just, or am I just off on another planet? Oh, you're off on another planet, Johnny. Everybody's been trying to tell you that for four years.

I mean, all this stuff, when we look at it all play out, Nick, it's, you can just see a clear agenda right across the board. It's clear that men are being canceled, that gender is being canceled, that all the rules. The moral rules that we've all lived by and built a nation on have all been completely cancelled and they're not being replaced with anything that we can rely on.

Well they, that's, that's the destruction of our, of our culture and our creed. I think that's if you can see across the West in general, which the West is built on Christian principles. That's where all of this madness is, is, um, you know, being pushed. We've got the mass immigration from all, you know, which is diluting our cultural identity and there's no like, I think they're, they're, they're bringing over about a million people a year now went from, you know, like, I'm just under 100, 000 to like a million.

Like that's. There's nothing good that comes from that. We don't, we already have a housing crisis, so it's a deliberate diluting down of our culture. Uh, and you can see that with the, the education system with all the Marxism that's being taught to the children, where they're basically making them hate their culture.

You know, we can't call it Christmas, you've got to call it X mas now. So it doesn't offend people. Uh, they, they, you know, and I'm going to, I'm going to speak the truth about this. Um, it's, it's deliberate that the, we Australia day, they call it invasion day. Like this is the sort of stuff that's, that's being perpetuated or the seeds that have been planted in the minds of the people.

children so that they hate their own culture and they don't realize actually the truth about the um, the Western culture is not that we're these evil people that invent all these evil things. Wherever we've been, um, you know, in history, there's been a mix of good and bad, but I would say overall, it's been a lot of good, a lot of courage, and there's amazing, this amazing history that's being rewritten.

By the academics in those Marxist institutions. And then obviously you have people coming over who don't even understand our laws or our, our culture or our values. And then we, we, you know, where the, where the locals here are being told that, no, you have to conform and bend the knee to everything else.

Well, no, that's, that's, that's completely backward. Um, and I'll give you an example, a mate of mine. Danny's, his name is one of my, one of my really good mates. Um, he, he rings me up. He says, he calls me Banjo, cause that was my fight name. Cause my last name is Patterson. So I was Banjo Patterson. And he, uh, he goes, Banjo.

He goes. I've got Buckley's chance of getting this job. And he's going for a job at Blue Scope Steel, right? So Blue Scope Steel is a great big steel ref refining company. You know, it's real man work, right? Yeah. What do you mean? He goes, there's 40 jobs. Yeah. Well, how many people got the jobs? He goes, it's not that, it's not that bad.

He goes, he said, 30 of the jobs have been assigned to women. And we're talking about man work. It's not, it's not like, you know, the HR department office work. These are, these are hands on, heavy labouring jobs. Um, you know, like rigging and all the rest of it. Which I, I've got no issue with women doing it, but I, when you're pushing a quota.

That's not merit by there's no merit basis to it. It's just, we need this many women in there to make it even. So 30 of the 40 jobs were assigned to women. So if you're a man who has the, the, the ability to do it well, you won't get that job. I said, well, so there's 10 jobs left. He goes, no, because out of the 10 jobs are assigned to men.

Five of them are assigned to people with ethnically diverse identities. So now he, he, so he can't get that job. You know, unless he's one of the five because of his race and his gender, because he's a man and because he's white, this is so, this is, this is a massive problem and I think it's one of the biggest problems we have because this is how a whole identity and if you have a belief in Christianity, Christian values, Christian principles, Then you can, this is the type of thing to get rid of them out of our society.

When all the big corporates who sort of own everything, um, can, can take away merits as a, as a Christian thinking, man, I think the best person for the job should get the job. No, no, not if there are, not if they're white, because we need more people from, from ethnic, diverse, um, cultures. Like what, what, what has that got to do with the job of refining steel?

Well, nothing because it's all political and it's political because they want to bring in the new, the new policies and they want to bring in the new culture. And they, and this is happening only in the Western countries. It's not happening everywhere else in the world. It's only in the West. And this is not racism at all.

This is, well, it is, you know, then it is a, I think the whole thing is, is racist because it's, it's putting one race or one cultural identity over another, um, and gender as well. But what I'm saying is racist. I'm just pointing out that, that values and merits are being thrown to the wayside. Um, because of some ideology and some hope that these people can create a, a dystopian, um, future where, which is multiculturalism, which goes back all the way back to the ancient as Syrian, um, um, occupation of, of, you know, like the Middle East and other areas when they would invade, we're talking like 3000 years ago, they would, they would subjugate, um, a, um, a city state.

They would, they would. Bring all these people from different parts of the empire into that city state and remove the other people and disperse them through throughout the empire. So that way you've got multiple cultures, multiple, um, languages, multiple gods that they worship, different cultures. And that way they couldn't unite together against the oppressors because they were too divided.

And I could see it. It's as clear as Blind Freddy can see it. So these are the issues that we have, um, and I think we need to, until we start speaking about them openly and having the courage to speak about these problems, we're not going to be able to resolve them. But if we can, if we can get onto that quickly and get to people and reach them at their mind, um, and start coming up with solutions, and, Defending our culture, our Christian roots and our Christian values and realizing that the Marxist ideology that's been taught to our children and our friends children and the next generation is all rubbish and breaking those narratives down so that, you know, the, the Western people don't hate themselves and think that they're evil and that they have to comply with, with everything.

I mean, they're bringing in Islamic prayers into the state schools. But they don't, you can't have Christian praise in there. Like it's deliberate, it's obviously deliberate. Look, there's so much going on too at the moment. Um, I, I noted with interest, uh, Tracy Holmes, who happens to be married to a former host of, of, uh, Q& A, Stan Grant, uh, was on that panel show 10 days ago.

And boy, didn't she rip it into the mainstream media. And, and they're driving this culture, let's be honest. They're the propaganda ministry driving the culture. And the way she pursued that. And also a former detective sergeant who fought against domestic violence and child abuse laying into the politicians.

I mean, I don't like Q& A, but I got quite a bit of satisfaction out of watching that play out. And Millie Fontana was on that program as well. She was one of the audience, and she posed some very interesting questions. Do you feel, Nick Patterson, that the narrative is starting to turn in the favor of freedom?

Yes, absolutely. And it's, I think it's going to be a rush to, to getting that critical mass active and confident and courageous enough to, to break down all of those narratives before that next generation comes through completely indoctrinated. Because they just, they just want our children to be gay communists.

That's what they, that's what they want, you know, um, just confused communists, um, useful idiots. That's what they do. They're not building any strength and any resilience in them. And they don't want resilient, strong people. So once I think the parents need to really instill good, solid values within them, within their children.

But the problem is this is multi multi, um, generational, uh, loss of those values and that identity where people, a lot of people believe that, you know, where the, where the evil people and, and, you know, we've done all these

evil things and it's, it's, it's, it's like, hang on a minute. Like, I mean, like the whole, the whole saying sorry thing, like, you know, that was, that was just more political rhetoric for, for the, for the indigenous.

It wasn't a, I can't say sorry for something that I didn't do. And if my ancestors didn't, my ancestors didn't, you know, my Polish ancestors didn't on my, on one side and, and my Scottish ancestors didn't on the other side. And then I've got some of them were convicts as well. And they didn't come over here because, you know, Because they chose to, they were forced to come here.

So the idea that, you know, I have, I have to say, sorry, it'd be like, Hey, you know, three generations ago, you're, you know, you're great, great. Oh, your great grandfather did this to, to my, you know, great art. And, um, I think that you should apologize. It's like, I didn't do that. I can only be accountable. I can't, I can't repent for the sins of somebody else.

And that's it in a nutshell. Um, yeah. They've managed to get that idea across that that's the right thing to do. Uh, and, and sadly our culture has been, um, diminished enough that they accepted that collectively, not the majority, but a lot of them did collectively went along with it. And it was wrong. So you can see it's been, it's been planned for a long time.

It's that Fabian socialist, um, playbook of wear the people down, break them down until they're so weak and then come in full force and, and take over the society. And that's what they're doing to us. But we have the ability to change it if we can just work together. And be inspired enough to, to stand, to stand up for the truth and to inspire others to do the same and to realize that the things that are inside of us, like our, our, our truth and our justice and all those spiritual things, spiritual things like courage that you can't put in a box and say, here's a box full of courage.

I want to give it to you. You can't give, it's not a physical thing. It's a spiritual thing. If we can start being focused on those spiritual elements, um, and make those elements more valuable than all the physical stuff, um, we can then inspire others to do the same. And that's the only way forward here, because the police and these people who are just you know, switching their conscience off and, and doing, allowing all these awful things to happen in our society and choosing not to look, um, they're not strong to the very core of who they are.

They don't really believe in it. Whereas you and I know to the core of our, our being that this, these agendas are wrong and that I'm here on this earth for this reason. And this is the truth to stand up to you and speak the truth, whether you like it or not. And that's what Jesus did. He would call out the, the authorities, you know, the, the lawyers he'd call them out.

And even his, the disciples would say, I think you offended them. He didn't care if he offended them because the truth is, is more important than their feelings. But as society it's, it's, it's real. Not, it's not at the moment and we need to change that and we can do it. It's just hard work. And it'd be less work if we had many hands because many hands makes light work.

But if we have, if we have, you know, a smaller group of people doing this, we just have to work harder, but it can be done. Um, and I'm, I'm a firm believer that it can be done, which is why that I'm working on some of these other projects, which I wanted to actually talk to you about one of our, we've got an event coming up as well, um, which is, you know, focused on, on inspiring people.

I'm giving them that confidence to, um, Well, let's, let's go to, let's go to that part of the story. So tell us what you're planning. It's a mid to late August. Yeah. So now that I'm not doing, um, I'm not doing, um, you know, giving all my time to court cases and I'm not being dragged through, through the, through the, um, through the courts for ridiculous reasons, um, I've started.

Working on, and I was always doing projects before anyway, um, because it's, it's something that I like to do is find solutions and I'm working with, um, with a guy named Tom Barnett. I don't know if you know, Tom is my

mate, Dave Armstrong. So he used to be the, um, the manager of Amy Park and he used to sponsor me as a, as an athlete when I was in my prime of my flight career.

And we've, we've, um, we've done some business together as well, uh, in the past. Um, and he's, he's sort of the main. Brains behind, uh, this, this event, and it's going to be an event like no other. And if you can give me a share link, I can just show, go show you a few things. Um, yeah. And, um, and another guy, Darren Dixon's involved and we've got some international speakers and we've got music, we've got, um, different.

different performers performing. So, um, I'm just going to go to the website. So it's called the Living Free Festival. It's the 23rd to 25th of August, 2024 in the Pillar Valley, New South Wales. Now, I don't know this region very well. Um, but, um, uh, you know, Dave and, um, Tom, they know the area quite well, and they've got this amazing property.

And we've got, we've got a bunch of speakers. We've got some international speakers. That are coming over like Cal Washington. He's from empower movement. Um, which is a, um, and you can go and look at their website and you click on. on the individual and yeah, and they, they operate this, um, uh, it's actually a Christian ministry, but it's, it's based on putting liability.

Like they've got a, they've got this part of their ministry, which is putting liability back on the big corporations. Um, you know, I've got Tom Barnett, I'll be speaking there. Um, Dave Armstrong. Dale Holmes, if you know Dale, um, Dottie, you might know Dottie Jansen. I don't know all these people personally.

There's my mate Darren Dixon from Constitution Watch. He's going to be speaking there. Um, we've got musical artists that are going to be there. So we've got And, and these, these are really good musicians, many of which have had, uh, you know, a lot of sort of mainstream, um, opportunities and some of them have turned them down because of their conscience.

Uh, let's have a look at one of them here. This is Kayda. So she was, um, so she was, um, let's have a look at her website actually. And you can just, so if people are interested, it's just livingfreefestival.org, um, and we're That's in northern New South Wales, I gather. Pillar Valley's up around Byron somewhere.

Yeah. So, so hi, I'm Kate. I'm a singer songwriter with a passion for telling, um, telling through music, books and film conversation. I've been blessed with opportunities to record in America, even singing the national anthem at a major league baseball game in San Diego. It's 25, 000 plus streaming fans. I'm currently writing a recording with some fellow Aussie producers and I'm excited to share this new chapter and continue to explore the depths where my soul is guiding me with it.

So yeah. is high level. We're going to have high level music and these are people that are, that are freedom people who have a conscience and they, um, and they want to be part of this event. And this is an event unlike, um, and you can get, you can get tickets here. Got frequently asked questions for people, you know, is camping available?

Can I hire a TB? So it's going to be an event where. We're all going to come together, have an awesome time. There's going to be speakers, music, it's all the audio visual sound. Everything is going to be set up and it's like it's professionally done. So there's been a huge investment there, but there's also going to be, um, workshops, food trucks, stuff for the stuff for the kids.

It's going to be brilliant. And it's something that hasn't happened. Through the freedom movement and specifically people with those, those Christian values. And it's not religious in any way, but with those Christian values and those, those good empowering, um, that they could empowering ideology that we need to go move forward into faith and confidence with a, with a positive outlook, because there's so many people in the freedom movement.

They're, they're weighed down with fear and doubt and worry. Don't worry about it. Don't don't, whatever you, what's the Bible verse say, you know, the light of the body is the eye. If your, your eye be single, your whole body will be full of light. But if that light be darkness, how great should be that darkness.

So if we focus on, on the positive things and we realize we have a great future ahead of us, God never said that, you know, It's all going to go bad and you're going to suffer. He said, you'll be, you'll suffer for the truth, but don't worry. I'll defend you and I'll lift you up and I'll, and I'll protect you.

So we have all of this great stuff and all these great blessings to realize. Um, and this is an event specifically targeting people, um, in a way that will sort of target their conscience and their confidence to make them stronger, to make them willing to, uh, to find out what their true calling is. And to be actively involved in doing that without the fear.

It's about getting rid of the fear because fear is the weapon that they use. I mean, look at the jabs. How many people said, look, you can't win. Just go along with it. You can't win. And I'd always say to them, what do you mean? You didn't even fight yet. You've given up before you've even put up a fight, at least put up the fight first.

And if you get beat, at least you're still in honor. If you get But at least fight, fight to the very end. Well, when people realize that they can actually win because they're around people that are, that are, um, you know, I guess nourishing those ideas that you can accomplish, and there'll be a lot of people and speakers who have accomplished big things.

I think like how Washington's been involved in some cases over there and doing some notices that have literally had. Like whole states have to change their policies. And in Canada, he's from Canada. Um, there's all these really unique people and they're not all the biggest name people, but they're the people that have, you know, with, with our group, then the people that we've agreed have the, um, the most value to add to that.

That's needed in our freedom community. Well, it looks like a great event and it's a good location and it'll be a good time of the year too. That time of the year is really good. Yeah. So if people want to get tickets, um, we've got a, um, a promo code that, that cause all the organizers with a promo code on banjo.

So if you buy tickets, um, and I'll just, I'll just show you where it is. The weather, if you go to, um, tickets here, it's for the whole three day event, you know, and there'll be, um, you click on here and you fill out, you know, you fill out the details. Um, But there's a promo code here. You just put in banjo.

Um, and if you put that in, you'll get a little discount. And, um, yeah, I mean, we just want people to be there and be a part of it. And if this goes well, we'll continue to do these because I think that's something that's really needed because the, the. The destructive forces out there have all sorts of, um, events for, and this is family friendly.

So you bring your family, there's no age restriction. It can be any age, and that's always healthier rather than isolating just young people here or just all, but it's always good to have people of all different ages because that's the real community. Um, but if there's events out there that. That get a lot of young people in as well.

Um, specifically that's who the, the, um, I would say the elites, um, the, the ruling class want to target. Um, but there's nothing good that really comes from these events. Like they're, they're, the music festivals are filled with drugs. They're filled with all of, all of the wrong things. Um, and, and a lot of the, and, and music that is destructive to the mind, not always, but a lot of it's destructive, whereas this is going to be all music and, um, And speaking, that's going to be empowering, strengthening, and it's going to be so well organized that I'm so confident that everybody that comes is going to say, this is amazing.

I want to do it again. Because we need this, we need something like this, and we need to make it something that's fairly regular. You know, even like, you know, if we could get them every, every, you know, few months if we could do events like this would be amazing. But we have to trial the first one and see how we go.

Um, so if anyone wants to support this event and wants to get away for, for three days from the 23rd to the 25th and be a part of something that's going to be history in this country, um, that's going to inspire and uplift you and give you power. Um, and also connections, the networking connections of speaking to people who, um, you know, who might be so well aligned with you and have potential. Maybe they, they've got plans to do certain things or they're doing a project and then you, you might have the missing bit that they need or you might say, Hey, I wanna be a part of that.

How can I be involved? And this is how these things happen. You need to meet people. It, it's, it's much more, um, powerful being in person with around those people than it is to be like talking to them on the phone or communicating on live. Well, it's clear that a lot, that way, too many people in this country are mining for darkness.

They're, they're going down rabbit holes. And they need to come up for air. The sun rises every day. It sets every evening. And, you know, we still live in an amazing country with a great many amazing people in it. And you are one of them, Nick Patterson. And we thank you for coming on, mate. I think the police in Victoria thought they would have been.

Looking at cauliflower ears and a pug nose, thought they would have been targeting some kind of mug, but you are articulate. You are fair dinkum. You're the real deal. And, uh, the country's better off for people like you, mate. And we thank you for coming on. I really appreciate it. I appreciate what you two are doing as well.

You do a great job and, um, and you're helping to break down the narratives as well. And, you know, we just work together and that's how we have a positive outcome that's maximizing. Absolutely. And you agreed before we recorded to bring it out with a prayer tonight. Would you do that for us? I'd love to.

Our father in heaven, thank you for the, for the blessings and the inspiration, the power that you give to us. Thank you for the bright light that you put into our minds. and help us to find those captive souls that are lost, that are feeling the fear, who are feeling the doubts and are overcome with these destructive elements.

And we pray that you will empower us and that you will lead us and you'll guide us and that you'll continue to place stumbling blocks before our enemies and give us the power to bring goodness and light into this world again. Give us strength, give us courage and know that we love you father and we love our brothers and sisters and we even love our enemies and this we pray in Jesus name.

Amen. Amen to that. And look, folks, keep focusing on the positives. There's plenty of them out there. AstraZeneca, Johnny, has been pulled from the market. Uh, it's good it didn't happen at the beginning. The irony of that hoodie, isn't it? You know, Channel 7 turn up with 18 police cars and tonight they're, uh, presenting the fact that AstraZeneca has been removed worldwide.

Well, now the wheel turns. Yeah. Now, we've got to ask the question. Are the health authorities who are really concerned about our health? Now going to fund, uh, massive checks on people who've had AstraZeneca to make sure that they're going to be okay. And are they going to be offering them some proper solutions?

Because we have the experts that can give them that if they want it, if they're serious. The answer to that is of course a big no. Lots to unpack in the coming days. We're going to be interviewing a wonderful lady who four years ago last Friday lost her teenage son in Victoria due to suicide and she puts the blame squarely on Daniel Andrews feet for that.

Uh, also Daniel Andrews has been spotted in a Melbourne tram looking rather gaunt and thin and narcissists when they're cut off from their power source tend to go that way, Nick. They lose their energy and, uh, I want to see him have enough energy to face trial. There's no doubt about it. That man needs to face trial because that's the right thing to do.

Don't forget if you love somebody and you haven't told them it's vitally important. You do. You may save their lives. It's still ours and we can still make a great big difference in it. So we can do that by following people like Nick Patterson, supporting him.
